Dear SDCERS Retiree:

SDCERS is currently accepting nominations for an election to fill the **remaining term of the vacant Retired Trustee seat** on the Board of Administration. In accordance with City Charter Article IX; Section 144, the Retired Trustee is elected by the retirees of SDCERS.

ELIGIBILITY

All nominees for the Retired Trustee seat must meet the following requirements:

- Be an SDCERS retiree formerly employed by the City of San Diego; and
- Submit a Nominating Petition (see reverse), signed by a minimum of 10 other SDCERS Retirees, to the SDCERS Board Secretary, Cynthia Joyner, at 401 West A Street, Suite 400, San Diego, CA 92101, no later than **5:00 P.M. on Friday, June 24, 2016**.
- **The election is anticipated to be completed in July. Following the election and swearing in by the City Clerk, the retired trustee will attend their first regular SDCERS meetings in September 2016.**

RESPONSIBILITIES

The Retired Trustee will:

- Serve out the remainder of a four-year term ending March 31, 2019, and
- Be expected to attend and participate in all regularly scheduled Board meetings, and
- Accept assignment to one or more Board committees, attend committee meetings, and complete Board-related work assignments and training as necessary.

Candidates must have sufficient time available to properly fulfill the obligation and duties required by the Board. Members of the Board receive no compensation from SDCERS for time served on the Board.
